

Providence College School of Business MBA Program Non-Matriculated Student Application

The PCSB MBA Program offers students an opportunity to complete up to two courses on a non-matriculated basis subject to the approval by the MBA Program Director.

To take courses as a non-matriculated student, an individual must meet the following requirements:

- 1) Completion of an undergraduate bachelor's degree
- 2) Have achieved an undergraduate cumulative GPA of greater than 2.70/4.00

Students who have met the minimum requirements must complete a non-matriculated student application form. The MBA Program will review non-matriculated student applications and course requests approximately one week prior to the start of the new term or after orientation. If your application is accepted, registration for MBA courses occurs, on a first come first serve basis, approximately one-week prior to the start of the new term. In addition, non-matriculated students will need to demonstrate business proficiency and meet prerequisites as applicable. Priority will be given to students who have completed an application for the MBA Program.

Please note, grades received in MBA courses by non-matriculated students may be used as part of the application for admission into the MBA Program and if admitted, may be used towards a student's MBA GPA. Please be aware that graduate students are required to maintain a cumulative GPA of 3.0 on a 4.0 scale.
