

# Providence College School of Business MBA Program Change Leadership Management Certificate

Management certificate students take MBA classes alongside current MBA students during the summer and fall. The program is taught by top MBA faculty with real-world input from executive fellows representing a variety of industries. Students must attend all course sessions to receive their certificate of completion.

Students applying to the Change Leadership Management Certificate program must meet the following requirements:

- 1. Completion of an undergraduate degree
- 2. Have achieved an undergraduate cumulative GPA of greater than 3.0

Students register for three Management courses that, once completed, will count towards the Change Leadership Management Certificate. Students who successfully complete the certificate program may use the nine Management credit hours towards the PC MBA Program.

Students who complete the Change Leadership Management Certificate program with a 3.3 GPA or higher and who have a minimum undergraduate cumulative GPA of 3.0 from an accredited institution, may be eligible for expedited admission into the PC MBA Program, which includes consideration for a GMAT waiver.
